Level IV 23 - 32 points (7 ½ of which must be for experience, 5 of these must be teaching in a co-op preschool, 2½ in a PCPO school, 6 of which must be for academics, including continuing education)

Level V 33 - 42 points (including requirements for Level IV)

Level VI 43+ points (including requirements for Level IV)
